ENTRANCE REQUIREMENTS FOR CANINE AND FELINE CAMPERS

Must be 4 months of age or older. Must be spayed or neutered if over 6 months of age. Dogs must have Bordatella (canine cough) Vaccine within the last 6 months and current on Distemper and Rabies Vaccines. Canine Influenza Vaccine is recommended but not required. We recommend that the Bordatella and Canine Influenza Vaccines be administered at least 2 weeks prior to boarding. Cats must be current on Rabies and Distemper Vaccines. Pets must be in good health and flea/tick free. If found to have fleas/ticks, preventative treatment will be given at pet owners expense. Must be non-aggressive and not toy protective to participate in Day Camp. Must have completed application and credit card number(s) on file. The Canine Day Camper & Boarder must successfully complete Camper Behavioral Interview.

LATE FEES - Your pet(s) will be overnight boarded if you are more than 15 minutes late after closing. You will be charged the standard boarding fee.

CANCELLATION POLICY - We ask for you to cancel 48 hours in advance of your day camp or overnight reservation. Day Campers are charged the normal rate for a no-show and boarders are charged a minimum of a two-night cancellation fee. 72 hours notice is required to cancel a holiday boarding reservation without a financial penalty.

AGGRESSIVE DOGS - We do not accept aggressive dogs into the Day Camp or Overnight Boarding Programs. Our thorough interview process screens for aggression. If an accepted dog exhibits unacceptable behavior, the dog is given a timeout and the owner is informed of the incident. We will then work with the canine camper's owner to resolve the situation; we may conclude at any time that a dog is not appropriate for participation in our Day Camp and Boarding Programs.

FEEDING- Day Campers- If you wish your dog be fed lunch, you must bring food in baggy or container clearly labeled. We occasionally offer treats unless you specify otherwise. **Overnight Guests-** We can accommodate special diets if needed at no extra charge. Please bring food packaged by serving in a bag or container with your pet's name clearly labeled. If you prefer, we can provide dry dog kibble at no cost to you. Canned wet food will be a charge of 2.00 per day.

MEDICATIONS- Should your pet require medications during his/her stay, we will happily to accommodate that. Oral medications will be administered per your instructions at no extra charge. Injectable medications and Ear or Eye medications can be administered for a small fee which is based on type of medication, frequency of administration and cooperativeness of pet. You must bring medications clearly labeled with your pet's name and instructions on dose, frequency and route (oral, eye, ear).

WHAT TO BRING TO CAMP- Your dog must have a Quick Release Collar and tag with your current contact information as well as a leash when entering The Dog Cabin. You may feel free to bring in your pet's favorite toy. No need to bring bedding as we provide comfy bed and fleece blanket for each pet. Please be advised that The Dog Cabin can not be held liable for lost or damaged belongings. Please label all belongings. (Let us know if your dog is prone to chewing bedding) ***The Dog Cabin provides bedding to each pet; if destroyed by pet, his/her owner will be held responsible for replacement cost of up to \$30.00. Let us know if you don't want us to provide bedding.***

OUTDOOR TERRAIN- Please be advised that the outdoor terrain at The Dog Cabin is made up of tumbled pea gravel. The Dog Cabin chose this terrain based on the fact that it makes for easy clean up and can be sanitized daily with pet safe sanitizer. A very small percentage of dogs are prone to tender or broken down paws (most often new guests and dogs that are not accustomed to terrain other than grass). Please let us know if you think your dog may be at risk for tender paws and The Dog Cabin staff will make every effort to monitor and modify his/her play to minimize issues with paws. Most dog's paw tenderness resolves with rest and decreases in severity with every visit. We find our regular guests don't have issues with tender paws. Also, it is very important that you let us know if your dog is prone to ingesting non-food items, particularly rocks and stones. Please be aware that The Dog Cabin, LLC can not be held liable for costs related to medical attention your dog may require for treatment to tender paws or ingested pea gravel.

PAYMENT POLICY - Fees for Services & Products: The canine camper's owner agrees to pay for camp fees, services or products with the credit cards listed on the front of this application or by cash or check. By listing your credit cards on the front of this application you are allowing The Dog Cabin, LLC to debit your credit card account for services, fees or products. You agree to pay an administrative fee for any returned check, or debit problems, such as non-sufficient funds, closed account, frozen or declined credit or similar circumstances. Refunds: There will be no refunds on services already provided such as day care, boarding and grooming. Products purchased can be refunded or credited with valid receipt within 30 days of purchase.

Memo of Understanding:

* I understand that The Dog Cabin LLC, its owners and employees, will exercise due care to protect the health and safety of my pet while in their care. I understand that The Dog Cabin's Day Care and Boarding service is an open play environment and because of this there are inherent risks, which even when monitored, may result in but not limited to the following: a) Transfer of a communicable illness such as canine cough (also known as Bordatella virus), Canine influenza, Puppy warts and parasites. b) Injuries, usually benign, such as broken nails, sore pads, puncture wounds, abrasions and cuts. If injury, illness or death occurs, The Dog Cabin will attempt to notify me immediately to receive specific instructions on how to proceed or to advise me that my pet(s) is being taken to its veterinarian on file. If The Dog Cabin staff is unable to reach me or emergency contact, I give permission to The Dog Cabin, LLC to seek any medical attention necessary and agree to pay for all charges incurred.

* I understand that the services of Dr. Brothers and the staff of the Middletown Veterinary Hospital may be retained to provide medical care in case of illness or injury. I hereby waive and release the Middletown Veterinarian Hospital, its owners or employees from any and all liability of any nature for any injury, death or loss of my pet while receiving veterinary care during its stay at The Dog Cabin, LLC. I consent to the release of medical information about my pet to the Middletown Veterinarian Hospital by my veterinarian on file. I agree to pay all veterinarian charges incurred.

* I understand if I ask for more than one dog/cat to be placed in the same kennel for boarding, I assume liability for any injuries they cause to each other.

* By entering my pet into The Dog Cabin, I hereby waive and release The Dog Cabin, its owners or employees from any and all liability of any nature for any injury, death or loss of my pet resulting from their actions or from the action of my dog/cat or any other dog/cats while in the custody of, or on the grounds or surrounding area of The Dog Cabin.

* In the event my dog/cat causes injury to another dog/cat or to a person while at The Dog Cabin, I agree to indemnify and subrogate The Dog Cabin or its owners from any action, which may be brought against them, and for any defense, settlement, or judgment against them. I will assume all liability for the actions of my dog/cat and agree to maintain personal liability insurance to cover me in the event of such an incident.

* I understand that I may not neglect to pick up my pet by the time he/she is scheduled for pick up without prior notification and approval by The Dog Cabin, LLC. I further understand that any pet that is left at The Dog Cabin without any notification by me or my representative will be considered abandoned on the 14th day after scheduled pick up. I understand that if I abandon my pet, The Dog Cabin, LLC, by default, will assume primary ownership of my pet and may therefore take any action necessary to re-home him/her. I understand and agree that if I abandon my pet at the Dog Cabin, LLC I relinquish all my rights to custody of my pet and will have no recourse of action against The Dog Cabin, LLC. I lastly agree that I will still be held responsible for any and all charges incurred while my pet is in the care of The Dog Cabin, LLC including, but not limited to, Day Camp, Overnight Boarding, veterinary and re-homing expenses.
